The Board of Review may meet as many more days as deemed necessary to hear questions, protests, and to equalize the 2021 assessments. Thursday, March 11, 2021 at 6:00 p.m., if needed, is tentatively scheduled to complete appeals or action of the Board of Review.

A resident or non-resident taxpayer may file his or her protest before the Board of Review by letter, without a personal appearance by the taxpayer or his or her agent. All written appeals must be received no later than Monday, March 8, 2021 by 4:30 p.m. E.S.T. Property owner agents/representatives must provide a letter of authorization to the Board of Review signed by the property owner.
