Trustee Manor inquired on the process to expand a parking lot. Zoning Enforcement Officer/Community Development Director Kim Fortner advised that she is not able to accept site plans for an expansion due to the moratorium and the proposed ordinance prohibits any expansions.

Attorney McCormick asked if the attorney letter was sent to the Township as she would like to review.
