## **BOARD COMMENTS**

Clerk Smith apprised the Board that the 2005 Chevrolet Suburban was involved in an accident on August 28, 2024, and was initially held at Allen Chevrolet due to ongoing litigation. Once released for repairs, it was determined to have a bent frame, classifying it as a total loss.

Following this, Chief Hernandez and Clerk Smith visited Groulx Automotive to discuss a replacement and was informed that a new vehicle would have a two-year waiting period. Chief Hernandez then contacted Allen Chevrolet and received a quote of \$33,000 for a 2012 Chevrolet Suburban (3/4 ton).

After reviewing these options, we discussed purchasing a brand-new, police-rated Tahoe instead. These vehicles are designed for demanding use and come pre-wired for most of the Fire Department's equipment, making them a more suitable and efficient long-term solution.

Chief Hernandez also highlighted the recurring issues experienced with the previous Suburban, specifically the constant need to replace batteries and alternators due to the high energy demands of the installed equipment.
