**Consider recommending revocation of River Raisin Event Center Corp Class "C" liquor license at 14750 LaPlaisance Rd., Ste. H110-140 for violation of Monroe Charter Township Code of Ordinances, Ordinance No. 149, Liquor License Ordinance, Section 6, C, Restrictions of Licenses.**

**QUESTIONS AND COMMENTS FROM BOARD.**

Patricia McCormick, Township Attorney presented facts to the Board for the consideration of the revocation of River Raisin Event Center liquor license that is currently pending. June 16, 2015 the Monroe Charter Township Board recommended the application of the River Raisin Event Center Corporation for an on-premise liquor license. On August 13, 2015 the River Raisin Event Center Corporation submitted its initial paperwork to the Michigan Liquor Control and they received that application on September 1, 2015. On July 13, 2016 the Michigan Liquor Control Board approved the River Raisin Event Center application for a new Class C liquor license. On August 3, 2016 they requested required fees and additional paperwork in order to issue the license. Based on research nothing has happened since that date. No further action has been taken by River Raisin Event Center and the application remains pending and no license was issued. There are pending permit requests for Sunday sales and dancing and entertainment. Several others have been canceled. On May 14, 2021 River Raisin Event Center took action to dissolve the corporation and the entity no longer exists.


