

Monroe Charter Township Monroe County, Michigan Precinct Descriptions

Precinct #1

Bordered on the North by the City of Monroe, starting on West side of So. Telegraph Rd. at 805 So. Telegraph Rd., East to I-75, South on I-75 to East Dunbar Road Overpass, West on North side East Dunbar Road to So. Telegraph Rd., and North on East side of So. Telegraph Rd. to 805 So. Telegraph Rd., POB.

Precinct #2

Bordered on the North by So. Custer Rd. between Herr Road and Western Ave. (to include only 654 Western and 830 Western), 2355 S. Custer Rd. through 1869 S. Custer Rd., starting at 654 Western through the back of 830 Western to Patterson Dr. bordered by the City of Monroe on the East side, continuing South to W. Seventh Street bordered by the City of Monroe on the North side of West Seventh St., and going East on W. Seventh St. to land behind 020-063 (Monroe Mold), going North to 740 and 741 Palmwood then going East to S. Telegraph Rd. then South on West side of So. Telegraph Road to French Creek, to West on French Creek to Herr Road, and North on Herr Road to So. Custer Road, POB.

Precinct #3

Bordered on the North side of E. Dunbar Road by Precinct #1 at Hull Rd. and E. Dunbar Rd. to I-75 Overpass then starting on South side of E. Dunbar Road and Hull Road going East to I-75 Overpass, then including both North and South side of E. Dunbar Road to Lake Erie, following Lake Erie South to North side Woodchuck Creek, going West to (M-125) So. Dixie Hwy., going North on East side of So. Dixie Hwy. to E. Albain Road, going East on South side of E. Albain Road to Hull Road, going North on East side of Hull Road to E. Dunbar Road and Hull Road, POB.

Precinct #4

Bordered on the North side of E. Dunbar Rd. by Precinct #1 between (M-125) So. Dixie Hwy. to Hull Road, then going South on West side of Hull Road to North side of East Albain Road proceeding West to (M-125) So. Dixie Hwy., going North on East side of So. Dixie Hwy. to East Dunbar Road, POB.

Precinct #5

Bordered on the North side of W. Dunbar Road by Precinct #6 from Raisinville Road to So. Telegraph Road and Precinct #1 from So. Telegraph Road to S. Dixie Hwy., then going South on West side of (M-125) So. Dixie Hwy. to North side of Woodchuck Creek, South side bordered by LaSalle Township, then West on Woodchuck Creek to Goutz Road, then North on Goutz Road with LaSalle Township and Raisinville Township bordering on the West side of Goutz Road, to W. Albain Road at 3249 W. Albain Road, continue North through vacant Township property then going West to include 2902 W. Albain Road, then North in vacant property that connects to W. Dunbar Road at Raisinville Road, POB.

Precinct #6

Bordered on the North by the Raisin River starting at the East side of Raisinville Road, going East to (U.S. 24) So. Telegraph Road, South on So. Telegraph Road to (M-50) S. Custer Rd., going West on North side of So. Custer Road to include 1458 S. Custer Rd. thru 1610 S. Custer Rd., going North to include Oak and Howard Dr., except 496 Howard, being bordered on the West by City of Monroe then going West at Raisin River turning South at 1880 Riviera to S. Custer Road, bordered on the East by City of Monroe, then West on S. Custer to include 1888 S. Custer to Herr Road, then South on West side of Herr Road to French Creek, going East on South side of French Creek to (U.S. 24) So. Telegraph Road, going South on West side of So. Telegraph to W. Dunbar Road, going West on North side of West Dunbar Road to Raisinville Road and continue on East side of Raisinville Road to Raisin River, POB.
